HISTORY of THE FPE

This year, the Board undertook the major task of gathering information from previous Board Presidents to better document the FPE's history. The history presented here is a concise summary of that significant project.

The FPE began in 2015 with a group of graduate students from Princeton Seminary and Princeton University, who organized the first Summer Symposium at Baylor University in 2016. Their aim was to develop a network of early career social ethicists and moral theologians working broadly within the Protestant tradi-

tions. At the heart of their vision was also cultivating a network of friends—a collaborative community that cares about the role of the academy and the role of churches in building a more just society.

A central feature of the FPE is the summer Symposium. The Symposium provides an opportunity for members of the FPE to gather, share their work,





hear from scholars in the field and activists on the ground, and to engage the community through public lectures and/or roundtables. The FPE is especially committed to offering its members professionalization opportunities and facilitating discourse on the work of Christian ethicists in academy, church, and society given shifting landscapes in higher education.

To date, the FPE has held summer Symposia at Princeton Seminary, Baylor, Notre Dame, and Vanderbilt, with keynotes from Jonathan Tran, Gerald McKenny, Keri Day, Willie Jennings, and Melissa Snarr. We are a sliding-scale dues-based organization.

In 2022, the Board launched a new, elegant website in order to better communicate the vision and mission of the FPE to future members and potential funders. The website features the work of its members and the Fellowship's role in facilitating professional collaboration.



PROFESSIONAL CONDUCT POLICY

After several years of determined efforts from each of the members of the Profession al Conduct Committee—including William Boyce, Hilary Scarsella, and Brandy Daniels—the Board is proud to present a Professional Conduct Policy for approval from the Fellowship's membership. Central to this policy is a commitment to survivor-centered care.

lifts up the vulnerable, challenges
injustice, and asks us to stand in
solidarity with those who experience
abuse. A survivor-centered response to
testimonies of myriad forms of violence
is one that answers this call.

FINANCIAL ACHIEVEMENTS

In 2022, the Board, with the help of our esteemed alum Elisabeth Kincaid, registered the FPE as an official 501(c)(3) non-profit. The Board also elected member Jimmy Haring to be our treasurer and collected membership dues for the first time.

This year, our Treasurer opened a non-profit bank account, filed our taxes, and streamlined dues collection.

FUTURE GOALS

Since its inception, the FPE has faced the challenge of annually raising funds to support the Symposium. We generally have to start fresh each year to raise funds from the institution hosting the Symposium, as well as any other external sources we can find. Since instituting membership dues in 2021-2022, we have had a small, steady source of income, though not nearly enough to support our annual activities. We've therefore essentially been operating "paycheck-to-paycheck" each year.

To eliminate this annual scramble and cultivate financial sustainability, the FPE is looking into new strategies for raising funds. We are pursuing a few different avenues. We have gotten some traction with centers and offices devoted to professional development at universities with which a good number of our members are affiliated, either as graduate students or as alumni. This seems to be a largely untapped source of funding, especially if the FPE continues to lean into professional development programming during the annual Symposium.

Our large number of ordained members and members pursuing ordination also opens up possibilities for accessing denominational funds. This would likely not represent a large amount of money, but enough to make an impact in our annual budget.

We are also continuing to explore the potential of mid-size to large grants from grant-makers like Lilly, Louisville, and Wabash. Finally, we are considering the development of institutional partners with universities that have consistently expressed commitment to our existence and mission. This could look like developing a rotation among these member institutions for our Symposium, as well as multi-year funding commitments tied to the FPE's commitment to offer graduate students and alumni opportunities for sharing and publishing scholarship, networking, and developing professional competencies.
